He was a Visiting Professor at the University of Texas, and studied International Human Rights at the International Human Rights Institute in Strasbourg, France. He taught International Human Rights at the St. Mary's Institute on World Legal Problems in Innsbruck, Austria in 1992.

The Justice Foundation is the lead counsel for Norma McCorvey, formerly "Roe" of Roe v. Wade, and Sandra Cano, the "Doe" of Doe v. Bolton, in their effort to overturn the two landmark cases that brought legalized abortion on demand to America. "Both women are deeply concerned and have come to the conviction that abortion is not the answer for women who are in a vulnerable pregnancy," said Allan Parker, President of the Justice Foundation.

Mr. Parker is the author of numerous works on school choice and a frequent lecturer on education topics. He and the Justice Foundation were selected in 1996 by the Texas State Board of Education to evaluate the Texas Open-Enrollment Charter Program.

Prior to teaching, Mr. Parker was in the general civil practice of law as a trial lawyer. He was Board Certified in Civil Trial (1987-1992) and Personal Injury Trial Law (1988-1993) by the Texas Board of Legal Specialization.

Mr. Parker received his J.D. degree with high honors from the University Of Texas School Of Law in 1979. He was an Associate Editor of the Texas Law Review, a Chancellor, Order of the Coif, and Order of Barristers for his outstanding advocacy skills. He graduated Phi Beta Kappa from the University of Oklahoma with a B.A. in Economics in 1974.
