Are We Pro-Lifers Anti-Choice?

Recently I was accused of being "Anti-Choice". My accuser asserted that my beliefs and actions were solely for the purpose of "taking choice away from women."

My attempts to explain my position as being one of human rights for all people, both born and the pre-born fell on deaf ears. My arguments about how from a scientific point of view a new human life clearly begins at conception/fertilization were dismissed out of hand. My arguments about the right to life being the most fundamental right any person has since all other rights depend on it and it is wrong for someone to unjustly deprive anyone of his (or her) natural (and God given) right were derisively dismissed. My arguments from human development and embryology to show that the beginning of the human person is the same as the beginning of the human being (i.e. conception/fertilization) again carried no weight.

Instead my opponent in the debate kept coming back to the idea that I was simply "Anti-Choice" and I was trying to force my will on society and oppress other people.

My heavens, who wants to be "Anti-Choice"? The freedom to choose is generally a good thing and who would be opposed to a good thing like that? People who have no choice are usually people who are powerless or in a desperate situation. Forcing my will on other people? Was I really a crazed dictator trying to oppress women and their male partners? Is that what my participation in the Right to Life movement had reduced me to? A petty despot who wanted to make the world a worse place?

Finally in a flash of clarity the fog was rent as under and I saw more clearly what was going on here. My opponent was attempting to twist reality by twisting language.

Language, if it has any meaning, is related to real things. The clearer the language used in the discussion, the more clearly it describes the reality to which it is related. For example, I have conveyed more meaning when I say "the green, Adirondack chair next to the oak tree in my backyard" than if I just say "the chair".

So let us explore and "unpack" this notion of "Anti-Choice" and oppression.

We in the Pro-Life movement are not trying to dictate our petty notions of how it should be to anyone. We are fighting for justice, equality and human rights for all people, both the born and the pre-born. In any civilized society, laws are enacted to protect the rights of especially the weak and the defenseless. These laws are not arbitrarily and unjustly imposed but instead they are enacted by the proper authorities since the laws are reasonable, just and they serve to promote the good in society.

The murder of an innocent human being is a grievous wrong since the person murdered is unjustly deprived of his or her right to live. We can all agree that society should take steps to prevent this from occurring.

If it happens to an adult, it is of concern to the community. If it happens to a child, again the community has an interest since age has no bearing on whether the person has basic human rights, such as the right to live. If it happens to a person *in utero*, the community of course has an interest since the location in space of the person has no bearing on fundamental rights. If it happens to a person in a Petri dish (an embryo) again it is a concern for the community since again physical location and age are both irrelevant.

Now what about this idea of "Choice"? (I capitalized the word since people who support abortion seem to think it is the most important issue.)

The notion that one can have choice separate from what is being chosen is nonsense. Father Frank Pavone of Priests for Life demonstrates this fact when he lectures and he instructs his audience that on the count of three they should choose. He counts out "one, two, three" and then he says, "Choose!" Suddenly the audience is confused since of course he never told them what to choose from.

The 2009 Session of the General Court of New Hampshire

Pro-Life advocates will have their hands full this session. Among the bills being considered this session are a reinstatement of parental notification with the necessary judicial bypass and an assisted suicide bill.

A revised parental rights amendment will be introduced into the Senate this session. This is key to the people defending their right to oversee the medical care of their children (parental notification) and other parental rights, such as home schooling and parenting style.

Always remember that Part 1, Article 38 of the New Hampshire Constitution makes you, the people, the interpreters and enforcers of the Constitution of the State of New Hampshire. You are required to study the Constitution, consider its principles in your selection of legislators and governor, and hold the legislators, members of the executive and the judiciary accountable to the Constitution. Yes, Judiciary can and do (regularly) violate the Constitution.

Dan Itse State Representative Epping and Fremont Cynthia Dudek, an insurance agent based in Michigan, has written an article arguing that the health risks of abortion, hormonal contraceptive use and in vitro fertilization adversely impact the U.S. economy. [1] Her article comes at a time when U.S. health care costs have soared from \$75 billion in 1970 to \$1.973 trillion in 2005 and the U.S. economy is reeling under the weight of a recession.

Therefore, it is not difficult to understand that the consumer must bear the cost when increased numbers of women and children develop serious illnesses or conditions because of an unsafe, but common surgical procedure (abortion). Some serious risks of abortion include breast cancer, pre-term births, infections, cerebral palsy (for babies from later pregnancies), post-traumatic stress syndrome, etc. These risks can be detrimental to the financial well being of health insurers and the businesses they serve and even impact the nation's economy.

Knowledge of the link between abortion and premature birth has been available since the 1960s. The knowledge that only full term pregnancy protects women from breast cancer, but abortions do not, has been available since 1973. The purveyors of abortion, however, have consistently misrepresented it as "safe," when in fact it is lethal.

Rooney et al. reported that, last year Byron Calhoun's team calculated the "annual increase in initial neonatal hospital costs" in their article for the Journal of Reproductive Medicine. [3] They estimated the costs to be over \$1.2 billion for babies with cerebral palsy resulting from their mothers' prior abortions. That figure is based on an estimated 1,096 additional cases of cerebral palsy among low birth weight babies (under 1,500 grams).

Big Abortion's propaganda machine will continue its drumbeat for abortion by repeating the Big Lie that it is a "safe procedure" until the grassroots rise up to protest this horrendous exploitation of women, the crippling of babies and the financial hardship it has caused the rest of society.

40 Days for Life

Praise God! 614 lives spared during this fall's campaign across the country!

One of the most important things we can do for moms and babies in danger is to be at the clinic to save them and to pray for them.

This fall, people all over the State of New Hampshire took part in our first 40 Days for Life campaign. At Planned Parenthood in Manchester and the Feminist Health Center in Greenland we had people praying in front of the abortion clinic from September 24 through November 2. At the Feminist Health Center in Concord we also had a presence during some of the 40 days.

God blessed us tremendously during this effort with at least three babies saved, and hundreds of people praying at the clinic, including at least nine different priests. God also handled the schedule Himself, sending people always at just the right time, and in Manchester, we had someone praying close to 12 hours a day for 40 days. I want to thank every single person that came out to pray. You are such a blessing!

Besides meeting many wonderful people, the best thing about praying at the clinic was the knowledge that we were doing something legal, peaceful and concrete to show the public, the clinic workers and the world that people care about the mothers and babies. While praying at the clinic, we could see the people who needed our prayers the most. Some of these people may not have had any one else to pray for them.

Many of the people that took part in the peaceful vigil, had never been to pray at an abortion clinic. Many came at least once a week. These dedicated volunteers came back again and again because they knew God wanted them there. Many of them are still coming! They were pleasantly surprised to find out that it is not scary. Christ wants us there to be a witness of His Love for those going into the clinic.

We will be able to tell our children and grandchildren that during this terrible period in history, "I was on the front lines, I made a difference."

Even though 40 Days has ended, the clinics are still open, and we need your help.

Please consider praying in Manchester on Tuesdays, Greenland on Thursdays, and Concord on Wednesdays and Fridays. These are the most urgent days since these are the days the clinics do abortion. If you can not be at the clinic, please pray for the children scheduled to die.

We need also help in West Lebanon! If you live nearby, please give us a call so we can put you in touch with someone to pray with at that clinic.

I ask you, can you get a group together of friends, or people from your church, and pray at one of the clinics once a week? Once a month? <u>It is urgent</u>. The best way is to have a (small or large) group of people praying and then one person be designated to talk to the girls entering. Please call us if you need signs or literature. Please prayerfully consider coming to the foot of the cross to pray for an end to the tragedy of abortion.

When people speak of being "Pro-Choice" what they mean is that they support the choice of abortion in society, which is the deliberate murder of a pre-born human person. The notion of "being personally opposed, but" is a cowardly avoidance of the real issue. Would we accept that baloney from someone who said "I am personally opposed to slavery but I support a person's right to own slaves"? Would it be any more acceptable with child molestation, rape, armed robbery, ethnic cleansing?

How is it that "Pro-Choice" has come to be seen as almost a desirable and noble thing and "Pro-Life" has become the same as "Anti-Choice" and therefore a detestable and ignoble thing?

January: We participated in the NH Awakening Primary events Saturday the 5th and Sunday the 6th.

We attended or provided written testimony for four bills. We spoke to Jr. & Sr. High students at Jesse Remington High School. We participated in CPR Action discussions. We held the Annual MFL, report available.

February: We testified for hearings for three more bills and made new contacts with other conservative voters/activists. We sent approximately 3000 postcards provided by John Kalb requesting Governor Lynch veto the repeal of Parental Notification.

March/April COPP established a PO Box, and grew dedicated volunteers. Julie spoke at St. Luke's and had at least four other speaking engagements through spring/summer and made many new contacts. We provided testimony for a few more bills.

May: We participated in the Chocolates for Choice fundraiser picket. We spoke at the National Day of Prayer Breakfast, representing the need to protect the right to Life.

During this time we put the Prolife Training Camp together, worked with legislators and candidates about legislation, also keeping up with correspondence with various conservative groups and supporting young/new prolife ministries.

June: We held the Prolife Training Camp, report available. We had a table at Market Square Day in Portsmouth.

July: We held a table at the St Benedicts' Conference. We held a booth at SoulFest in Gilford, NH.

August: We sent pre-primary newsletter.

September: COPP began 40Days for Life with a rally, prayer outreach in Manchester, Greenland and Concord. The preparation had been months of coordination. We represented NHRTL at the Cornerstone Banquet.

October: We held our Annual Fundraising Banquet with Patrick Lee, bioethicist. We held a ProLife witness in Nashua.

40Days continued. We were represented at the Maine Right to life Convention and provided a rally in Greenland with UCLA student Lila Rose.We participated in the UNH program Project Search with Rebecca Kessler.

All year, every two or three weeks, we sent e-alerts to keep people updated with what is going on around the State, including Prolife witnesses, pickets, events, legislation etc. This year many of our members did send letters to editors and shared them with us either fyi or for review first. We also participated in a couple of interviews by phone and tv. Our members maintained a presence outside of the clinics three to five, and sometimes six days, each week. We provide literature as requested on a continuing basis.

All of this activity cost, time, money and talent. We hope that you will be moved to help us in whatever way you can. Prayer is indispensible and mingled with action, it is a powerful combination that will kick-in the doors of hell and set the captives free. Those without a voice need you. Numerous studies have linked abortion to other problems such as substance abuse, suicide, and higher rates of psychiatric care. Further, many women abort because of pressure, coercion, disinformation and even force from others. In one survey, 64 percent of women who had abortions reported being pressured by others, while 84 percent said they did not receive enough counseling to make a decision.⁸

Dear Friends,

I hope you are all doing well, and starting to get back into the swing of the new school year. I have something that I really want to share with all of you...

It was just a few short weeks ago, in the middle of this beautiful summer, that I was able to experience something that I will never forget. A close friend of mine, Kelly, gave birth to her fourth baby... and a few days later had a funeral for that same baby. It was n't a surprise to Kelly or her husband, Kevin, because they had known that their beautiful baby wouldn't live very long.

When Kelly was 11 weeks pregnant she found out that her baby was diagnosed with ancephaly. Kelly was heartbroken, but knew that God often has a plan that is sometimes different from our own. Through the grace of God, Kelly made it through her pregnancy and delivered her baby by c-section at Hunterdon Medical Center in Flemington. Beautiful baby Will David lived for 61 minutes, and was showered with love-- from everyone including the family (who traveled from as far as Texas to be there), to the medical staff that supported Kelly and Kevin throughout their entire experience.

Many people questioned Kelly at the beginning-- how can you be strong enough to go through with this... why would you put yourself and your family through all of this....? But in the end we all knew. This beautiful little soul showed all of us that life is precious, and to love that life is even more precious. A friend of Kelly's told her, "If I found out that my two year old was sick and didn't have much time to live-- what would I do? What would we all do? We would love that child, love him until the end." Well, that is exactly what Kelly did. She loved Baby Will-- and so did everyone else- until the end.

The wake and funeral for Will David was beautiful-- far beyond what I could ever describe to you. He was treated like a king- as we all should be at the end of our lives.

There were beautiful pictures of Baby Will and his family in the album -- Kelly feels honored to be able to share them with all of us There is another side to this story.... unfortunately, as not every baby is as blessed as Will David. I need to share this with you as well, as difficult as it is. Abortion kills thousands of babies every day. Please keep the conversation going. We all need to know the truth.
