NHRTL Fights to Prevent Tax Dollar Subsidies to Planned Parenthood

New Hampshire Right to Life has been actively involved this year in preventing tax dollars from going to support the state's largest abortion provider: Planned Parenthood of Northern New England. For years. Planned Parenthood (PP) has received millions of dollars in Title X funds from both the state of New Hampshire and the federal government. This past summer, three executive councilors: Dan St. Hillaire, Dave Wheeler, and Ray Wieczoreck, courageously voted to stop funding the state's largest abortion provider with taxpayer's dollars. In addition, the councilors asked that the state find health clinics and/or hospitals to be recipients of the federal Title X funds. At least one community health clinic asked to be given the opportunity to submit a bid to obtain the Title X grant funds. Nevertheless, Senator Jeanne Shaheen intervened and asked the Department of Health and Human Services to immediately provide PP with over a million dollars in Title X funds. The federal department of Health and Human Services complied and sent PP the money without any opportunity for competitive bidding. During the 2008 election cycle, Senator Shaheen had received over \$390,000.00 in campaign contributions from the abortion lobby including from Planned Parenthood Federation of America, Emily's List and NARAL.

NHRTL has formally objected to this grant but HHS has failed to respond to NHRTL's protest. Also, NHRTL has made a Freedom of Information Act (FOIA) request to the Department of Health and Human Services for its communications with PP resulting in this million dollar "bail out." HHS has been stonewalling and delaying production of its communications and it may be necessary to file an action in federal court to force production of these documents. NHRTL is committed to ensuring transparency in government and guaranteeing that funds are not unlawfully diverted to fund abortions at PP.

NH Right to Life thanks all the legislators who worked so hard this year to pass parental notification, HB 329. A study by Michael New, an assistant professor of political science at the University of Alabama, studied the effects of informed-consent laws, Medicaid funding rules and parentalnotification laws for minors — rules that existed, by 2005, in dozens of states. He found that all three approaches had significant results in certain populations. Parental-notification laws were correlated with a 15 percent decline in in-state abortion rates for minors.

Reflections

Being part of anything larger than yourself can sometimes make you forget where you came from.

For me, I remember three girls I used to talk with in high school. They told me that the **US Supreme Court just** decided to legalize Abortion. I had no clue as to what they were talking about and asked them what was Abortion. They looked at me like I was a complete idiot. I did not know what to say and they were arguing so passionately I decided to stay out of it. Looking back, if I knew then what I know now, I hope I would have realized it was not one of my better decisions, but I was a kid and did not know the ways of the world. Later in life I met a young woman who said she was going to get an abortion. Again I said nothing. I rationalized, that it made no matter what I said she would do it anyway, she had the right under the law. That is another decision I regret. Many years later, I heard a request in Church for someone to work on the Respect Life Committee. This opportunity I decided to not pass up.

However, after a couple years and much frustration, it became apparent that this committee would only go so far and only do so much, but it did expose me to people involved in other groups that did more to prevent abortion. In the beginning, I thought a woman should be able to get an abortion if she was raped. I also thought she should be prevented from getting an abortion if the father opposed it. Obviously I needed to learn more about many things, but that is where I started. Abortions for convenience were always very had

Over time, I learned that Birth Control Pills do not prevent conception. They cause an immediate abortion! They are not sold that way, so.. Some businesses lie. I realized based on medical evidence and my faith that the baby is a baby whether in the womb or not. The baby is a separate human being, deserving and worthy of equal protection under the law. This changed my opinion on permitting an abortion because of rape or permitting an abortion if both parents chose to kill the kid. Nobody has a right to kill an innocent human being. I also learned that I can't stop abortion myself. It takes more than one person to expose a child to that danger. It will take more than one person to stop it. This is a team effort.

I learned that both prayer and works are needed as an offering to God when asking forgiveness for this sin. I also learned that the only thing that will heal the wounds from personal guilt and regret is forgiveness from God. I am thankful that many people as well as God had patience with me and helped me to understand and deal with the truth.

There remains much work and prayer to be done. You don't have to be perfect, just forgiven.

Did you know there is also a group of people who pray at the Derry Planned Parenthood? They are there to witness to the teens on Wednesdays from 2:30-3:30 pm. Did you know teens can get birth control pills without a parent's knowledge or permission? And most likely, the pills will be subsidized with your tax dollars, since most teens will fall into the low income category! Please pray that God will stop this travesty and give wisdom to these teens. This clinic also refers for abortion and gives out "emergency contraception".

Pro-lifers Like to Live Dangerously?

Before the recent vote in Mississippi on a "personhood amendment" to the Mississippi State Constitution, U.S. Rep. Debbie Wasserman Schultz (D-FL), who is also the head of Democratic National Committee, expressed her opinion on the matter. She said that personhood amendments are "divisive, dangerous and destructive laws" and she also stated that "for the vast majority of Americans including people on both sides of the abortion issue, this is an extreme and radical step". The radical, extreme, divisive, dangerous and destructive idea that Rep. Wasserman Schultz was trying to protect the State of Mississippi from is the idea that human personhood begins at conception. I do not know if passing high school biology is expected or required of U.S. Representatives but perhaps a short refresher might be worthwhile.

A human sperm has 23 chromosomes and a human egg has 23 chromosomes. When the sperm penetrates and fertilizes the egg (this is traditionally referred to as conception), the chromosomes come together to form a unique creation: a single celled human person that contains a complete set of 46 chromosomes and a unique, individual DNA sequence. This single-celled human person, with the proper biological conditions, will under his or her own innate developmental initiative develop into an adult human person.

The one-celled person becomes a two-celled person and then a four-celled person. The cells keep dividing and soon there is an embryonic person and then a fetal person. After birth there exists a new-born person and then an infant person. The infant becomes a child, then an adolescent and finally an adult person.

To try to break this logical chain of personhood by saying for example that at three months in utero there is now a person but at two months and 29 days (27 days in February?) what exists is not a human person but is only a clump of human cells that can be discarded or experimented upon with no moral or ethical concerns seems to me the wrong way of thinking. I would say that being in favor of abortion, euthanasia and embryonic stem cell research is the radical, extreme, divisive, dangerous and destructive idea.

It is radical and extreme since in our culture killing one's fellow man is usually considered a crime.

It is divisive since by denying the personhood of some persons in society it deprives those people of their most basic human right, namely the right to live.

It is dangerous and destructive since by denying for some the right to live it puts everyone's right to live up for question and/or debate. If we can legally abort a child because this is an inconvenient time to have a baby, what prevents us from wondering whether it might be legal to give grandma a lethal injection (whether she wants it not) because she has become inconvenient? If only some lives have value who then decides which lives are worth living? A blue-ribbon commission in Washington appointed by the President?

I think that we need instead to focus on the inherent right to live that the human person brings to society rather than seeing the right to live as something that society gives to the individual. Personhood amendments in reality just serve to remind government of this reality. Respect for the dignity of man and the right to pursue life are the founding values of our country. It is truly a tragedy that some people in our society see these values as somehow dangerous.
